

DECLARATION OF FITNES, WAIVER AND QUIT CLAIM

hereby confirms and declares that:

1. I am participating in the 10th SINULOG DANCE CREW COMPETITION to be held on _____ - _____ with its elimination on January 07, 2017 - Sunday of my own free will, desire and volition.
2. I hereby represent and warrant that I am physically fit to participate and take part in the competition and have no known illness, physical defect, or adverse medical condition that would render me unfit to participate in the elimination and competition proper, I shall advise the competition organizers and committee in writing and shall accordingly refrain from participating in the competition.
3. I hereby authorize the competition organizers and committee to use my name, photographs and interviews in connection with the competition in broadcast and print media, video tapes, etc. without any monetary consideration.
4. I understand that if and when my identity is challenged by the competition organizers and committee, it is my responsibility to prove my identity.

7. If in my own opinion, the weather, temperature, humidity, competition environment or course condition on the day of the elimination and competition proper is not ideal or will

pose a risk to my health and safety, I shall voluntarily withdraw from the competition. I acknowledge that I am under no compulsion or pressure to participate in the competition.

If I insist on continuing the competition, I hereby acknowledge and agree that I do so of my own volition and risk, and knowingly and willfully waive and release all rights or claims, if any, that I may have arising from any injury/ies, illness or death that I may sustain or suffer, and I hereby hold the organizers and committees free and harmless from any liability arising from my said decision to continue with the competition.
